## Airport 2025 Burn Plan

## **RESOLUTION 2025 -005**

WHEREAS, the Ferry District manages the airport and parade ground lands and has previously contracted with the Fishers Island Conservancy to manage and develop the grassland within this area; and.

WHEREAS, the management plan for said lands requires certain sections to be burned annually to sustain the growth of grasses; and

WHEREAS, the NYS DEC requires the Ferry District to obtain a permit to conduct the burn upon the submission of a permit application and Burn Plan; and

NOW, THEREFORE, BE IT RESOLVED, that the Commissioners of the Ferry District authorize and direct Island Manager, David McCall, to sign the permit application and to submit all required documentation to the NYS DEC for the issuance of the Burn Permit, subject to the approval of District Counsel.

#### Discussion:

The area to be burned was discussed.

## Other:

A bid from Dicin Electric Co., Inc to replace the outdoor lighting fixtures around the ferry docks was reviewed for the installation of five lights for \$23,130. We expected this to be closer to \$8,000 or \$9,000. This bid will not be accepted until we get more information. One suggestion was to split the job and have another contractor do the mechanical aspect, then an electrician do the wiring.

On Tuesday, Commissioner Cashel and Geb Cook will be speaking at ICB about the Coast Guard house and the new ferry. This will be a factual presentation. Tom and Geb will touch base beforehand about this.

There are a few grants coming up that Geb is planning to apply to, for projects like boat slips and off ramps. This is due April 30, and the goal is to be ready with the grant writer by March 1. Commissioner Burnham pointed out that we should have a master plan for parking and traffic flow before we seek money for these other projects, saying that we need an overall map before we apply for a Port Authority Grant. Commissioner Burnham suggested that we get some proposals from developing consultants before the next meeting. Commissioner Cashel concurred and said that he could get in contact with some people. Commissioner Congdon pointed out that some of this may be in the Yale study, but not all the information we need.

Geb has still been meeting weekly with Maritime Consulting Partners and Glosten. There is a meeting about zero-emission ferries coming up that Geb would like to attend to get more information about the capabilities of these technologies. The meeting is March 4 in Arlington, Virginia. The Board of Commissioners approves Geb attending this meeting. Commissioner Burnham clarified that for the new boat, we will be using traditional technologies for the engine and trying to minimize environmental impacts with other components where possible. Geb added that the Cummins K-38 engine is what we want, but it may not fit. He is working with Glosten to determine this.
