Fishers Island Ferry District MINUTES Board of Commissioners

June 16, 2025 General Meeting at 4:00pm Fishers Island Community Center and Zoom

Chair Jim Reid called a meeting of the Board of Commissioners of the Fishers Island Ferry District (the "Ferry District") to order on June 16, 2025 at 4:01 PM at the Island Community Center and via Zoom.

Commissioners Heather Burnham, Tom Cashel, Dianna Shillo, David Congdon, and Jim Reid were present at the Community Center, as were Geb Cook, Dave McCall and Jessica NeJame. Jon Haney was present via Zoom.

Chair Reid established that a quorum was present. Everyone in attendance pledged allegiance to the flag.

Public Comment:

Gordon Murphy and Josh Theodore from the Fishers Island Waste Management District (FIWMD) discussed ongoing challenges with scheduling trash removal from the Island. Typically, there has been a spot for them 5 days a week on the 8:15 am. This was cut back to 4 days, then to 3, though it is now back up.

The trash needs to be removed from the Island, but it is unpleasant for passengers on a busy boat. Particular pain points are the Monday and the Tuesday runs, which have many passengers and commercial food deliveries respectively. Conversation ensued about potential solutions.

Could this be on a different boat? That depends on the drivers from CWPM. They say that the 8:15 am is the only time they can get drivers for. One option is to put more pressure on them, or to try a different boat (instead of the 5 am or the 4:15 pm, what about the 11:15 am?). Another option is to get Schultz to make runs; that conversation will happen this week.

Could the Munnatawket be run as an extra boat on Monday? It's possible, but it would impact the loading of freight and be a challenge to staff.

Monday mornings are especially tight, and FIWMD said that they could get away with doing four trips a week, but with three, they'd fall behind. Wednesdays, Thursdays, and Fridays will be booked out for them all the way through the summer to ensure that at least those days are set. Mondays and Tuesdays will be determined as they go. The Mondays after the Fourth of July and Labor Day weekends, it would be good to take FIWMD off the schedule.

Otherwise, they are fine to continue on Mondays until another solution is found. Collaboration towards a long-term solution will continue.

Todd McCormack asked the Board of Commissioners for permission to top some trees on Ferry property that are blocking his view of Race Rock Lighthouse. Conversation ensued about legal implications and the neighborly thing to do. Jim Reid will be the point person on this and meet with Todd to get more details, including which trees he would like cut.

Marine Update:

The summer schedule started on June 12. Fourth of July reservation traffic doesn't have a clear pattern yet. There's one sold out boat on the 6th or the 7th but the other boats have room. Next Friday, the 27th, is the school graduation. The 2:00 pm Munnatawket will run but the 5:15 Munnatawket is cancelled as there is a charter for graduation. The banner is up on the website and notice has gone out via email and social media. One more reminder should go out on Wednesday or Thursday.

The crew is doing a great job fitting folks on the boat and people are happy about that.

No major maintenance on the boat, just small items that are being taken care of.

Anchor still has issues, but bulk ticketing is going relatively well.
